INCLUDING the land conveyed by deed from Frederick W. Green to the Red Bank Manufacturing Company dated May 10, 1872, and recorded June 7, 1872, in the office of the Clerk of the Court of Common Pleas and General Sessions for said Lexington County in Book Y, pages 284-5;

TOGETHER WITH all the rights, privileges and powers heretofore owned by Maxe Gotha Mills to flood, pend, flow, overflow or back water upon any or all of the lands aforesaid (including the lands excepted and excluded as hereinafter provided), and to increase or raise the head of water in the pend upon such property, and to flood, pend, flow or overflow or back water upon any or all other land whatsoever.

AND INCLUDING specifically (without implied limitation of the general conveyance of rights, privileges and powers hereinabove contained), ALL THE RIGHT, PRIVILEGE AND POWER conferred upon Saxe Gotha Mills by a deed from J. Paul Corley to Saxe Gotha Mills, dated August 25, 1909, recorded August 26, 1909, in the office of the Clerk of the Court of Common Pleas and General Sessions for said Lexington County in Book 3-E, page 454, and also recorded August 26, 1909, in the office of the Auditor for said Lexington County in Book D, page 116, said right, privilege and power being as follows:

The right, privilege and power to increase the height and size of its mill dam and to raise the water in Red Bank Creek by pondage two feet and six inches above the then high water mark, and to perpetually flow, overflow or flood, or pend any of the lands then ewned by said Corley lying along and adjacent to said pend and creek by reason of the raise of water as aforesaid; said Corley, in and by said deed, having released said Saxe Gotha Mills, its successor and assigns from any and all damages that might arise or result from such overflow or pendage to any part, or parts, or all of the lands of said Corley lying on and along Red Bank Creek in said County and State, containing one hundred and fifty acres, more or less, known as the "Coward Place", and conveyed to said Corley by Henry A.
