I, John R. Shepherd, of Greenville County, S. C.

SEND GREETINGS:

WHEREAS I the said John R. Shepherd

in and by my certain promissory note, in writing, of even date with these presents AM well and truly indebted to
FIRST FEDERAL SAVINGS AND LOAN ASSOCIATION, OF GREENVILLE, in the full and just sum of ONE THOUSAND? FOUR HUNDRED AND
NO/100

(\$1,400.00) Dollars, with interest at the rate of six (6%) per centum per annum, to be repaid in instalments of FOURTEEN AND NO/100
(\$ 14.00) Dollars upon the first

day of each and every calendar month hereafter in advance, until the full principal sum, with interest has been paid; said monthly payments shall be applied first to the payment of interest, computed monthly on the unpaid balance, and then to the payment of principal; said note further providing that if at any time a portion of the principal or interest due thereunder shall be past due and unpaid for a period of thirty (30) days, or failure to comply with any of the By-Laws of said Association, or any of the stipulations of this mortgage, the whole amount due under said note, shall, at the option of the holder thereof, become immediately due and payable, who may sue thereon and foreclose this mortgage; said note further providing for ten (10%) per centum attorney's fee besides all costs and expenses of collection, to be added to the amount due on said note, and to be collectible as a part thereof, if the same be placed in the hands of an attorney for collection, or if said debt, or any part thereof be collected by an attorney, or by legal proceedings of any kind (all of which is secured under this mortgage); and in and by said note, reference being thereunto had, will more fully appear.

NOW, KNOW ALL MEN, That I John R. Shepherd

in consideration of the said debt and sum of money aforesaid, and for the better securing the payment thereof to the said FIRST FEDERAL SAVINGS AND LOAN ASSOCIATION, OF GREENVILLE, S. C., according to the terms of said note, and also in consideration of the further sum of Three Dollars to me

the said John R. Shepherd in hand well and truly paid by the said FIRST FEDERAL SAVINGS AND LOAN ASSOCIATION, OF GREENVILLE, S. C., at and before the signing of these presents (the receipt whereof is hereby acknowledged), have granted, bargained, sold, released and by these presents do grant, bargain, sell and release unto the said FIRST FEDERAL SAVINGS AND LOAN ASSOCIATION, OF GREENVILLE, S. C., the following described property to-wit:

"All that certain piece, parcel or lot of land, with all improvements thereon, or to be constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville,

and in the Town of West Greenville, Greenville Township, being composed of Lots Nos. 60 and 61 of a subdivision known as "Dorwood", as shown on plat thereof recorded in the R. M. C. office for Greenville County in Plat Book A, at pages 462 and 463, and having the following metes and bounds to-wit:

"BEGINNING" at an iron pin on the north side of Landal street at the joint corner of Lots nos. 59 and 60, and running thence along the north side of Landal street, S. 74-26 W. ¹⁰⁰ feet to an iron pin at the southwest corner of Lot No. 61, in line of property of the Honour Estate; thence along the line of the Honour property, N. 15-20 W. ¹⁵⁰ feet to an iron pin; thence N. 74-26 E. 100 feet to an iron pin at the joint rear corner of Lots Nos. 59 and 60; thence along the joint line of said lots, S. 15-20 E. 150 feet to the beginning corner. Being the same lots conveyed to me by Ed Ford and J. C. Patterson by deed of even date herewith not yet recorded."

Let No. 61 hereinabove described is subject to the right-of-way of a read across a portion of said lot along the west side adjoining the Honour property.
