Leonard may have acquired in, through or by said Indenture of Mortgage and said Supplemental Indentures, in and to the following described property, to-wit:

## Subdivision 1

All of the telephone system and property of said South Carolina Continental Telephone Company which is located within the city limits of the City of Sumter, in Sumter County, in the State of South Carolina, including all of the poles, switchboard, lines, wires, cables, telephones, tools, furniture and fixtures of said South Carolina Continental Telephone Company located within the city limits of the said City of Sumter even though not specifically referred to herein, belonging to said South Carolina Continental Telephone Company, used and useful in rendering telephone service in the said city, and all of the rural lines of said South Carolina Continental Telephone Company located in the rural area adjacent to the city of Sumter and served by the Sumter Exchange; but expressly excluding therefrom all toll pole lines of said South Carolina Continental Telephone Company in such areas, all toll wires of said South Carolina Continental Telephone Company wherever located, and all property of said South Carolina Continental Telephone Company in such areas constructed for the express purpose of rendering telephone and toll service to Shaw Field, South Carolina.
