LAND BANK COMMISSIONER  
AMORTIZATION MORTGAGE

KNOW ALL MEN BY THESE PRESENTS, That

Tarlie E. Moore and wife, Beulah C. Moore

of Greenville County and State aforesaid, hereinafter called first party, whether one or more, SEND GREETINGS:

WHEREAS, First party is indebted to the Land Bank Commissioner, acting pursuant to Part 3 of the Emergency Farm Mortgage Act of 1933, as amended, hereinafter called second party, as evidenced by a certain promissory note, of even date herewith, for the principal sum of Three Hundred

(\$ 300.00 - - - - ) Dollars, payable to the order of the second party,

together with interest from the date of said note on the principal sum remaining from time to time unpaid, at the rate of (5%) per centum per annum,

the first payment of interest being due and payable on the first day of November, 1945, and thereafter interest being

due and payable annually; said principal sum being due and payable in three equal, successive, annual

installments of One Hundred (\$100.00) Dollars each, and a final install-

ment of (\$ - - - - -) Dollars, the first installment of

said principal being due and payable on the first day of November, 1946, and thereafter the remaining installments of

principal being due and payable annually until the entire principal sum and interest are paid in full; all of which and such other terms,

conditions, and agreements as are contained in the said note, will more fully appear by reference thereto.

NOW, KNOW ALL MEN, That first party, in consideration of the debt as evidenced by the said note, and for better securing the payment thereof to second party, according to the terms of the said note, and the performance of the conditions and covenants herein contained, and also in consideration of the sum of One Dollar to first party in hand well and truly paid by second party, at and before the sealing and delivery of these presents, receipt whereof is hereby acknowledged, has granted, bargained, sold, and released, in fee simple, and by these presents does grant, bargain, sell and release in fee simple, unto second party, his successors and assigns, the following described lands, to wit:

All that certain parcel or tract of land containing Forty-two and 33/100 (42.33) acres, more or less, known as the R. R. Bishop Place in Fairview Township, Greenville County, South Carolina, located on the Log Shoals Public Road leading from Simpsonville to the Augusta Road, 12 miles southeast from the City of Greenville, S. C., BOUNDED on the north by property of Moore; on the east by property of Thompson; on the south by property of J. D. Clark, Byron Cox Estate and Log Shoals and property of Jones; and on the west by property of Rushton.

Said tract of land is particularly shown and delineated on plat prepared by W. J. Riddle, Surveyor, September, 1945, which plat is recorded in the R.M.C. Office for Greenville County, in Plat Book B, page 35, which plat and the record thereof are by reference incorporated herein.

First party further covenants and agrees that if at any time it shall appear to second party that first party may be able to obtain a Federal Land Bank loan on the property described herein, first party shall, on request of second party, apply for a Federal Land Bank loan to pay off the indebtedness secured hereby and shall accept such loan as may be offered to him by the Federal Land Bank if sufficient in amount to pay the indebtedness secured hereby and pay for any stock which it may be necessary for first party to purchase in obtaining such loan.

The debt secured by this mortgage which is recorded in Mortgage Book 337, at Page 298, having been paid in full, Federal Farm Mortgage Corporation, its executors and assigns, hereby certify that the debt secured hereby is hereby discharged and the mortgage is cancelled.
