(hereinafter referred to as Mortgagor) SEND(S) GREETING:

WHEREAS, the Mortgagor is well and truly indebted unto FIDELITY FEDERAL SAVINGS AND LOAN ASSOCIATION, GREENVILLE, S. "All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, on the Southern side of Perry Avenue in the Town of West Greenville, South Carolina, shown as lot No. 4, Section 1, Page 119 of the County Block Book and being more particularly described by metes and bounds, as follows:

BEGINNING at an iron pin at the corner of lot No. 3, as shown on said Block Book, and running thence with the line of said lot in a southern direction 192 feet to an iron pin on a 13-foot alley; thence with the northern side of said alley; thence with the northern side of said alley 80 feet to an iron pin, corner of lot No. 5; thence with the line of said lot in a northern direction 192 feet to an iron pin on Perry Avenue; thence with the Southern side of Perry Avenue in a Western direction 80 feet to the point of beginning; said premises being the same conveyed to the mortgagor by Nora Lee R.
