SEND GREETINGS:

WHEREAS we the said C. A. Cathcart and Marie W. Cathcart

in and by our certain promissory note, in writing, of even date with these presents are well and truly indebted to

four and one-half (4 1/2%)
(\$2,000.00) Dollars, with interest at the rate of 11 1/2% per centum per annum, to be repaid in instalments of TWENTY AND NO/100
