MORTGAGE

TO ALL WHOM THESE PRESENTS MAY CONCERN: I, P. L. Bruce, Jr.

(hereinafter referred to as Mortgagor) SEND(S) GREETING:

WHEREAS, the Mortgagor is well and truly indebted unto FIDELITY FEDERAL SAVINGS AND LOAN ASSOCIATION, GREENVILLE, S. C., (hereinafter referred to as Mortgagee) as evidenced by the Mortgagor's promissory note of even date herewith, the terms of which are incorporated herein by reference in the sum of Thirty-nine Hundred Seventy-five and No/100 - - - - - DOLLARS (\$ 3,975.00 ), with interest thereon from date at the rate of four (4%) per centum per annum, said principal and interest to be repaid as therein stated, and

"All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, Greenville Township, on the Northern side of McMakin Drive, near the City of Greenville, being shown as Lot No. 99 on Plat of the Perry Subdivision, recorded in Plat Book I at Page 33, and described as follows:

"BEGINNING at an iron pin on the Northern side of McMakin Drive, 212 feet West from Buncombe Road at corner of Lot No. 101; and running thence with the line of Lots Nos. 101 and 100, N. 10-17 W. 150 feet to a stake in line of Lot No. 1; thence with the line of said Lot, S. 79-28 W. 50 feet to a stake at the corner of Lot No. 98; thence with the line of said lot, S. 10-17 E. 150 feet to a stake on McMakin Drive; thence with the Northern side of McMakin Drive, N. 79-28 E. 50 feet to the beginning corner; said premises being the same conveyed to the mortgagor by Evelyn and Margurite Bramlett by deed dated December 12, 1945, recorded in Book of Deeds 284 at Page 173.
