WHEREAS, the Mortgagor is well and truly indebted unto FIDELITY FEDERAL SAVINGS AND LOAN ASSOCIATION, GREENVILLE, S. "All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, in Bates Township, on the eastern side of Third Street (formerly Lindbergh Street) at Slater, South Carolina, being shown as lot No. 26 of Block "C" on plat of the village of S. Slater & Sons, Inc. made by J. E. Sirrine & Company, July 10, 1940, recorded in Plat Book "K" at Pages 63, 64 and 65, and described as follows:
