TO ALL WHOM THESE PRESENTS MAY CONCERN H. Henry F. Smith

(hereinafter referred to as Mortgagor) SEND(S) GREETING:

WHEREAS, the Mortgagor is well and truly indebted unto FIDELITY FEDERAL SAVINGS AND LOAN ASSOCIATION, GREENVILLE, S. C., (hereinafter referred to as Mortgagee) as evidenced by the Mortgagor's promissory note of even date herewith, the terms of which are incorporated herein by reference in the sum of Thirty-five Hundred and No/100 DOLLARS (\$ 3,500.00), with interest thereon from date at the rate of four (4%) per centum per annum, said principal and interest to be repaid as therein stated, and

"All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, Greenville Township, on the Northern side of Orlando Avenue, near the City of Greenville, and being shown as Lot No. 54 on Plat of Leawood Extension, made by C. E. Jones on September 1, 1941, recorded in Plat Book M at Page 35, and described as follows:

"BEGINNING at a stake on the Northern side of Orlando Avenue, at the corner of Lot No. 55 and running thence with the line of said lot, N. 33-54 E. 150 feet to a stake, corner of Lot No. 34; thence with the line of said lot, N. 56-06 W. 50 feet to a stake at corner of Lot No. 53; thence with the line of said lot, S. 33-54 W. 150 feet to a stake on Orlando Avenue; thence with the Northern side of Orlando Avenue, S. 56-06 E. 50 feet to the beginning corner."
