MORTGAGE

TO ALL WHOM THESE PRESENTS MAY CONCERN: I, George E. Ballenger

(hereinafter referred to as Mortgagor) SEND(S) GREETING:

WHEREAS, the Mortgagor is well and truly indebted unto FIDELITY FEDERAL SAVINGS AND LOAN ASSOCIATION, GREENVILLE, S. C., (hereinafter referred to as Mortgagee) as evidenced by the Mortgagor's promissory note of even date herewith, the terms of which are incorporated herein by reference in the sum of Nineteen Hundred & No/100 DOLLARS (\$1900.00), with interest thereon from date at the rate of six (6%) per centum per annum, said principal and interest to be repaid as therein stated, and

WHEREAS, the Mortgagor may hereafter become indebted to the said Mortgagee for such further sums as may be advanced to or for the Mortgagor's account for taxes, insurance premiums, public assessments, repairs, or for any other purpose;

NOW, KNOW ALL MEN, That the Mortgagor, in consideration of the aforesaid debt, and in order to secure the payment thereof and of any other and further sums for which the Mortgagor may be indebted to the Mortgagee at any time for advances made to or for his account by the Mortgagee, and also in consideration of the further sum of Three Dollars (\$3.00) to the Mortgagor in hand well and truly paid by the Mortgagee at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold and released, and by these presents does grant, bargain, sell and release unto the Mortgagee, its successors and assigns:

"All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, in Bates Township, on Mellon Street and Tally Bridge Road in the Village of S. Slater & Sons, Inc., at Slater, being known and designated as Lots Nos. 15 and 16 of Block G, as shown on plat of the Village of S. Slater & Sons, Inc., made by J. E. Serrine & Company, Engineers, on July 10, 1940, which plat is recorded in the R.M.C. Office for Greenville County in Plat Book K at Pages 63, 64 and 65, and having, according to said plat, the following metes and bounds, to-wit:

"BEGINNING at an iron pin on the East side of Mellon Street, joint front corner of Lots Nos. 16 and 17 of Block G, and running thence with line of Lot No. 17, S. 66-25 E. 136.8 feet to iron pin, joint rear corner of Lots Nos. 10 and 11 of Block G; thence with the rear line of Lots Nos. 11 and 12, N. 16-27 E. 188.75 feet to an iron pin at or near the South side of Tally Bridge Road; thence S. 66-56 W. 148.66 feet; thence S. 31-39 W. 80 feet to the beginning corner."

Said premises being the same conveyed to the mortgagor by Pink McClain by deed dated February 24, 1941, recorded in Book of Mortgages 228 at Page 301.
