

MORTGAGE OF REAL ESTATE—GREM 7

TO ALL WHOM THESE PRESENTS MAY CONCERN

We, Wayman W. Henry and Helen B. Henry

hereinafter spoken of as the Mortgagor, send greeting.

WHEREAS We, Wayman W. Henry and Helen B. Henry is

justly indebted to C. Douglas Wilson & Co.

State of South Carolina, hereinafter spoken of as the Mortgagee, in the sum of — Fifty-Five Hundred — Dollars (\$ 5500.00), lawful money of the United States which shall be legal tender in payment of all debts and dues, public and private, at the time of payment, secured to be paid by

certain bond or obligation, bearing even date herewith, conditioned for payment at the principal office of the said C. Douglas Wilson & Co. in the City of Greenville, S. C., or at such other place either within or without the State of South Carolina, as the owner of this obligation may from time to time designate,

Fifty-Five Hundred & No/100 Dollars (\$ 5500.00)
on the 1st day of March 1946, and thereafter said interest and principal sum to be paid with interest thereon from the date hereof at the rate of 4 1/2 per centum per annum, said interest to be paid in installments as follows: Beginning on the 1st day of April 1946 and on the 1st day of each month thereafter the sum of \$ 44.20 to be applied on the interest and principal of said note; said payments to continue up to and including the 1st day of February 1960 and the balance of said principal sum to be due and payable on the 1st day of March 1960 the aforesaid monthly payments of \$ 44.20 each are to be applied first to interest at the rate of 4 1/2 per centum per annum on the principal sum of \$ 5500.00 or so much thereof as shall from time to time remain unpaid and the balance of each monthly payment shall be applied on account of principal. Said principal and interest to be paid at the par of exchange and not to the holder, it being thereby expressly agreed that the whole of the said principal sum shall become due after default in the payment of interest, taxes, assessments, water rate or insurance, as hereinafter provided.

NOW, KNOW ALL MEN, that the said Mortgagor in consideration of the said debt and sum of money mentioned in the condition of the said bond, and for the better securing the payment of the said sum of money mentioned in the condition of the said bond, with the interest thereon, and also for and in consideration of the sum of One Dollar in cash paid by the said Mortgagee, the receipt whereof is hereby acknowledged, has granted, bargained, sold, conveyed and released and, by these presents does grant, bargain, sell, convey and release unto the said Mortgagee and to its successors, legal representatives and assigns forever, all that parcel, piece or lot of land with the buildings and improvements thereon, situate, lying and being in Greenville Township, Greenville County, State of South Carolina, on the Western side of Augusta Road, near the City of Greenville, being shown as Lot No. 6 of Block A of Plat of Augusta Court, made by R. R. Bailey in April, 1923, recorded in Plat Book F at Page 124, and described as follows:

Beginning at a stake on the Western side of Augusta Road, 201.5 feet North from Augusta Court, at corner of Lot No. 5, and running thence with the line of said lot, S. 54-30 W. 246.7 feet to a stake in line of Lot No. 7; thence with the line of said lot, N. 57-37 W. 105 feet to a stake in line of property formerly owned by E. W. Carpenter; thence with the line of said property, N. 55-30 E. 270 feet to a stake on Augusta Road; thence with the Western side of Augusta Road, S. 24-35 E. 100 feet to the beginning corner.

Said premises being the same conveyed to the mortgagors by deed of Marie P. Bailey dated February 21, 1946 to be recorded herewith.

If the premises securing this loan shall be sold to a purchaser whose credit and general standing are satisfactory to the holder hereof, and if such purchaser shall assume all obligations in connection with this loan by agreement satisfactory to the holder hereof, the said holder will agree in writing not thereafter to hold the seller personally liable hereunder.

TOGETHER with the appurtenances and all the estate and rights of the said Mortgagor in and to said premises.
AND IT IS COVENANTED AND AGREED by and between the parties hereto that all gas and electric fixtures, radiators, heaters, engines and machinery, boilers, ranges, stoves and motors, bath-tubs, sinks, water-closets, basins, pipes, faucets and other plumbing and heating fixtures, mirrors, mantels, refrigerating plant and ice-boxes, cooking apparatus and appliances, and such other goods and chattels and personal property as are ever furnished by a landlord in letting or operating an unfurnished building, similar to the one herein described and referred to, which are or shall be attached to said building by nails, screws, bolts, pipe connections, masonry, or in any other manner, are and shall be deemed to be fixtures and an accession to the premises and a part of the realty as between the parties hereto, their heirs, executors, administrators, successors and assigns, and all persons claiming by, through or under them, and shall be deemed to be a portion of the security for the indebtedness herein mentioned and to be covered by this mortgage.
TO HAVE AND TO HOLD the said premises and every part thereof with the appurtenances unto the said Mortgagee, its successors, legal representatives and assigns forever.
PROVIDED ALWAYS, that if the said Mortgagor, his heirs, executors, administrators, successors or assigns, shall pay unto the said Mortgagee, its successors or assigns, the said sum of money mentioned in the condition of the said bond or obligation, and the interest thereon, at the time and in the manner therein specified, then these presents and the estate hereby granted shall cease, determine and be void.
AND the said Mortgagee, its successors, legal representatives or assigns, shall also be at liberty, immediately after any such default, upon a complaint filed or any other proper legal proceeding being commenced for the foreclosure of this mortgage, to apply for, and the said Mortgagee shall be entitled as a matter of right, without consideration of the value of the mortgaged premises as security for the amounts due the Mortgagee, or of the solvency of any person or persons bonded for the payment of such amounts, to the appointment by any competent Court or Tribunal, without notice to any party, of a Receiver of the rents, issues and profits of the said premises with power to lease the said premises, or such part thereof as may not then be under lease, and with such other powers as may be deemed necessary, who, after deducting all proper charges and expenses attending the execution of the said trust as Receiver, shall apply the residue of the said rents and profits to the payment and satisfaction of the amount remaining secured hereby, or to any deficiency which may exist after applying the proceeds of the sale of the said premises to the payment of the amount due, including interest and the costs and a reasonable attorney's fee for the foreclosure and sale; and said rents and profits shall, in the event of any default or default in the payment of said principal and interest, or any tax, assessment, water rate, or insurance, pledged and assigned to the said Mortgagee, its successors or assigns, who shall have the right to enforce after any such default to enter upon and take possession of the said mortgaged premises and to let the said premises and receive the rents, issues and profits thereof, and apply the same, after payment of all necessary charges and expenses, on account of the amount hereby secured.
AND it is covenanted and agreed by and between the parties to these presents that the whole of said principal sum shall become due at the option of the said Mortgagee, its successors, legal representatives or assigns, after default in the payment of interest for thirty days or after default in the payment of any tax, assessment or water rate for sixty days after the same shall have become due and payable, or after default in the payment of any installment hereinbefore mentioned or immediately upon the actual or threatened demolition or removal of any building situated on said premises.
AND it is further covenanted and agreed that the whole of said principal sum and the interest shall become due, at the option of the said Mortgagee, upon failure of any owner of the above described premises to comply with the requirements of any Department of the City of Greenville, S. C. within thirty days after notice of such requirements shall have been given to the then owner of said premises by the said Mortgagee, or if the said premises are not demolished, and a state of repair as they were at the date of this mortgage, reasonable depreciation alone excepted, and within sixty days after notice by the Mortgagee for the same to be made, and if the same shall fail to put the said premises in as good a state of repair as they were at the date of this mortgage, reasonable depreciation alone excepted. The Mortgagee shall be the sole judge of what constitutes such state of repair or reasonable depreciation.
AND it is further covenanted and agreed by and between the parties to these presents that the whole of said principal sum and the interest shall become due at the option of the said Mortgagee, its successors, legal representatives or assigns, after default in the payment of interest for thirty days or after default in the payment of any tax, assessment or water rate for sixty days after the same shall have become due and payable, or after default in the payment of any installment hereinbefore mentioned or immediately upon the actual or threatened demolition or removal of any building situated on said premises.
