MORTGAGE

TO ALL WHOM THESE PRESENTS MAY CONCERN: I, William Clifton Burch

(hereinafter referred to as Mortgagor) SEND(S) GREETING:

WHEREAS, the Mortgagor is well and truly indebted unto FIDELITY FEDERAL SAVINGS AND LOAN ASSOCIATION, GREENVILLE, S. C., (hereinafter referred to as Mortgagee) as evidenced by the Mortgagor's promissory note of even date herewith, the terms of which are incorporated herein by reference in the sum of Forty-two Hundred Fifty and No/100 DOLLARS (\$ 4250.00), with interest thereon from date at the rate of five & one-half per centum per annum, said principal and interest to be repaid as therein stated, and

"All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, Greenville Township, on the South side of Oregon Street, near the City of Greenville, being shown as Lot No. 5 of Lock L on Plat of Kanatenah, made by J. E. Serrine and Company August 25, 1923, recorded in Plat Book F at Page 130 & 131, and described as follows:

"BEGINNING at a stake on the South side of Oregon Street 60 feet West from Stewart Street, at corner of Lot-No. 6, and running thence with the line of said Lot, S. 26-30 E. 165 feet to a stake; thence S. 63-35 W. 60 feet to a stake, corner of Lot No. 4; thence with the line of said Lot, N. 26-30 W. 165 feet to a stake on Oregon Street; thence with the South side of Oregon Street, N. 63-35 E. 60 feet to the beginning corner."
