MORTGAGE

TO ALL WHOM THESE PRESENTS MAY CONCERN: I, William F. Manley

(hereinafter referred to as Mortgagor) SEND(S) GREETING:

WHEREAS, the Mortgagor is well and truly indebted unto FIDELITY FEDERAL SAVINGS AND LOAN ASSOCIATION, GREENVILLE, S. C., (hereinafter referred to as Mortgagee) as evidenced by the Mortgagor's promissory note of even date herewith, the terms of which are incorporated herein by reference in the sum of Thirty-Seven Hundred Fifty & No/100 DOLLARS (\$ 3,750.00), with interest thereon from date at the rate of four(4%) per centum per annum, said principal and interest to be repaid as therein stated, and

WHEREAS, the Mortgagor may hereafter become indebted to the said Mortgagee for such further sums as may be advanced to or for the Mortgagor's account for taxes, insurance premiums, public assessments, repairs, or for any other purpose;

NOW, KNOW ALL MEN, That the Mortgagor, in consideration of the aforesaid debt, and in order to secure the payment thereof and of any other and further sums for which the Mortgagor may be indebted to the Mortgagee at any time for advances made to or for his account by the Mortgagee, and also in consideration of the further sum of Three Dollars (\$3.00) to the Mortgagor in hand well and truly paid by the Mortgagee at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold and released, and by these presents does grant, bargain, sell and release unto the Mortgagee, its successors and assigns:

"All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, in Greenville Township, on the South side of Traxler Street (formerly Gypsy Avenue) known and designated as Lot No. 104 of Block E of East Park, Boyce addition, and having the following metes and bounds, to-wit:-

"BEGINNING at a stake on Traxler Street (formerly Gypsy Avenue) at corner of Lots Nos. 103 and 104, and running thence with the line of Lot No. 103, S. 13-30 E. 129 1/2 feet to a stake on an alley; thence with said alley, N. 86-30 E. 50 feet to stake, corner of Lot No. 105; thence with the line of Lot No. 105, N. 17-30 W. 141 feet to stake on Traxler Street; thence with Traxler Street, S. 73-30 W. 50 feet to the beginning corner."

"Also, all that other piece, parcel or lot of land adjoining the above lot, being known and designated as Lot No. 105 of Block E on plat above referred to, and having the following metes and bounds, to-wit:

"BEGINNING at a stake on the South side of Traxler Street (formerly Gypsy Avenue), corner of Lot No. 104, and running thence along Traxler Street, N. 73-30 E. 50 feet to stake at corner of Lot No. 106; thence with the line of Lot No. 106, S. 17-30 E. 152 1/2 feet to a 10-foot alley; thence with said alley, in a Northwesterly direction to a stake in line of Lot No. 104; thence with the line of said lot, N. 17-30 W. 141 feet to the point of beginning on Traxler Street."

Said premises being the same conveyed to the mortgagor by Ansel Vaughn and May Vaughn by deed of even date to be recorded herewith.

Together with all and singular the rights, members, hereditaments, and appurtenances to the same belonging or in any way incident or appertaining, and all of the rents, issues, and profits which may arise or be had therefrom, and including all heating, plumbing, and lighting fixtures and any other equipment or fixtures now or hereafter attached, connected, or fitted thereto in any manner; it being the intention of the parties hereto that all such fixtures and equipment, other than the usual household furniture, be considered a part of the real estate.
