MORTGAGE

TO ALL WHOM THESE PRESENTS MAY CONCERN: We, D. C. Hudgens & Mildred M. Hudgens
..... (hereinafter referred to as Mortgagor) SEND(S) GREETING:

WHEREAS, the Mortgagor is well and truly indebted unto FIDELITY FEDERAL SAVINGS AND LOAN ASSOCIATION, GREENVILLE, S. "All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, Greenville Township, near the Easley Bridge Road, being situate on the west side of Georgia Avenue, and known and designated as Lot No. 7 and a small portion of Lots Nos. 1, 2 and 6 on plat of property of Julia D. Charles, recorded in Plat Book E, Page 259, said lots being described in the aggregate as follows:

BEGINNING at a stake on the western side of Georgia Avenue, front corner of Lots Nos. 7 and 9; thence with joint line of said lots, S. 71 W. 200 ft. to stake at rear corner of Lots Nos. 6, 7, 8 and 9; thence along the rear line of Lots Nos. 6 and 7, S. 9-30 E. 50.9 ft. to a stake; thence S. 71 E. 40 ft. to a stake; thence S. 9-30 W. 30 ft. to a stake at rear corner of Lots Nos. 3 and 4; thence along the rear line of Lot No. 3, N. 71 E. 80 ft. to a stake at the northeast corner of Lot No. 3 thence with the dividing line of Lots Nos. 2 and 3, S. 9-30 E. 18.6 ft. to a stake; thence N. 71 E. 160 ft. to a stake on the west side of Georgia Avenue; thence with the west side of Georgia Avenue, N. 9-30 W. 99.5 feet to the beginning corner; being the same property conveyed to the mortgagor by E. Imman, Master, by deed to be recorded herewith."
