MORTGAGE

TO ALL WHOM THESE PRESENTS MAY CONCERN: We, Hoyt Graham and Etta Graham
(hereinafter referred to as Mortgagor) SEND(S) GREETING:

WHEREAS, the Mortgagor is well and truly indebted unto FIDELITY FEDERAL SAVINGS AND LOAN ASSOCIATION, GREENVILLE, S. C., (hereinafter referred to as Mortgagee) as evidenced by the Mortgagor's promissory note of even date herewith, the terms of which are incorporated herein by reference in the sum of Twenty-Two Hundred Fifty and No/100 DOLLARS (\$ 2,250.00), with interest thereon from date at the rate of six (6%) per centum per annum, said principal and interest to be repaid as therein stated, and

"All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, Greenville Township, near Melrose Avenue (now known as Greene Avenue Extension) and known and designated as Lot No. 27 of the Melrose Land Company property as shown on a plat recorded in Plat Book A at Page 157, said lot fronting 50 feet on Lady Street (formerly Walnut Street) with a parallel depth of 150 feet."
