MORTGAGE

TO ALL WHOM THESE PRESENTS MAY CONCERN: I, Wriston M. Smith, Sr.

(hereinafter referred to as Mortgagor) SEND(S) GREETING:

WHEREAS, the Mortgagor is well and truly indebted unto FIDELITY FEDERAL SAVINGS AND LOAN ASSOCIATION, GREENVILLE, S. "All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, in Greenville Township, near Judson Mills, known as Lot No. 51 on plat of American Bank and Trust Company made by R. E. Dalton, Engineer, and recorded in the Office for Greenville County in Plat Book F at Page 44 and having the following courses and distances according to said plat:-

"BEGINNING at an iron pin on the Southwestern side of Jamison Street, 284.9 feet West of Anderson Road, corner of Lot No. 52, and running thence with the line of said lot, S. 42-43 W. 190.4 feet to an iron pin in line of B. F. Martin; thence with his line, N. 46-32 W. 49.7 feet to an iron pin, corner of Lot No. 50; thence with the line of said lot, N. 42-43 E. 174.2 feet to an iron pin on Jamison Street; thence with said street, S. 53-40 E. 50 feet to the beginning corner."
