C., (hereinafter referred to as Mortgagee) as evidenced by the Mortgagor's promissory note of even date herewith, the terms of which are incorporated herein by reference in the sum of DOLLARS (\$ 4,300,00 ______), with interest thereon from date at the rate of _____five & one-half ______per centum per annum, said principal and interest to be repaid as therein stated, and WHEREAS, the Mortgagor may hereafter become indebted to the said Mortgagee for such further sums as may be advanced to or for the Mortgagor's account for taxes, insurance premiums, public assessments, repairs, or for any other purpose; NOW, KNOW ALL MEN, That the Mortgagor, in consideration of the aforesaid debt, and in order to secure the payment thereof and of any other and further sums for which the Mortgagor may be indebted to the Mortgagee at any time for advances made to or for his account by the Mortgagee, and also in consideration of the further sum of Three Dollars (\$3.00) to the Mortgagor in hand well and truly paid by the Mortgagee at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold and released, and by these presents does grant, bargain, sell and release unto the Mortgagee, its successors and assigns: "All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County in Greenville Township, on the Northwestern side of Melville Avenue, near the City of Greenville, of Greenville, being shown as Lot No. 19 on plat of Aberdeen Highlands made by Dalton and Neves, in November 1941, recorded in Plat Book M at Page 37, and described as follows:-"BEGINNING at an iron pin on the Northwestern side of Melville Avenue, 335 feet North from West Faris Road at corner of Lot No. 18, and running thence with the line of said lot, N. 44-34 W 198.3 feet to a stake in line of the M. D. Earle Estate; thence with the line of said property, N 51-31 E. 100 feet to a stake at corner of Lot No. 20; thence with the line of said lot, S.35-25 E. 195.5 feet to a stake on Melville Avenue; thence with the Northwestern side of Melville Avenue S. 51-58 W. 70 feet to the beginning corner."
