MORTGAGE

TO ALL WHOM THESE PRESENTS MAY CONCERN: I, Edward C. Wilson, Sr.  
(hereinafter referred to as Mortgagor) SEND(S) GREETING:

WHEREAS, the Mortgagor is well and truly indebted unto FIDELITY FEDERAL SAVINGS AND LOAN ASSOCIATION, GREENVILLE, S. C., (hereinafter referred to as Mortgagee) as evidenced by the Mortgagor's promissory note of even date herewith, the terms of which are incorporated herein by reference in the sum of Fifty-Two Hundred and No/100 DOLLARS (\$ 5,200.00), with interest thereon from date at the rate of four(4%) per centum per annum, said principal and interest to be repaid as therein stated, and

NOW, KNOW ALL MEN, That the Mortgagor, in consideration of the aforesaid debt, and in order to secure the payment thereof and of any other and further sums for which the Mortgagor may be indebted to the Mortgagee at any time for advances made to or for his account by the Mortgagee, and also in consideration of the further sum of Three Dollars (\$3.00) to the Mortgagor in hand well and truly paid by the Mortgagee at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold and released, and by these presents does grant, bargain, sell and release unto the Mortgagee, its successors and assigns:

"All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, in Greenville Township, in that section known as Sans Souci, about two miles North of

the City of Greenville, on the Northern side of Paris Mountain Avenue, and being shown as Lot Nos. 59 and 60 on plat of the Perry property, recorded in Plat Book O, at Page 45, and when described as a whole have, according to said plat, the following metes and bounds, to-wit:-

"BEGINNING at an iron pin on the Northern edge of a 5 foot sidewalk running along Paris Mountain Avenue, the said pin being the joint front of Lots Nos. 60 and 61, and running thence along the Northern edge of said sidewalk, S. 84-28 W. 120 feet to an iron pin, corner of Lot No. 58; thence with the line of Lot No. 58, N. 5-50 W. 155.6 feet to an iron pin, joint rear corner of Lots Nos. 58 and 59; thence N. 82-45 E. 120 feet to an iron pin, corner of Lot No. 61; thence with the line of Lot No. 61, S. 5059 E. 159.2 feet to an iron pin on Paris Mountain Avenue, the point of beginning."
