MORTGAGE

TO ALL WHOM THESE PRESENTS MAY CONCERN: I, Mrs. C. H. Massey
(hereinafter referred to as Mortgagor) SEND(S) GREETING:

WHEREAS, the Mortgagor is well and truly indebted unto FIDELITY FEDERAL SAVINGS AND LOAN ASSOCIATION, GREENVILLE, S. C., (hereinafter referred to as Mortgagee) as evidenced by the Mortgagor's promissory note of even date herewith, the terms of which are incorporated herein by reference in the sum of One Thousand and No/100 - - - - - DOLLARS (\$1,000.00), with interest thereon from date at the rate of six (6%) per centum per annum, said principal and interest to be repaid as therein stated, and

NOW, KNOW ALL MEN, That the Mortgagor, in consideration of the aforesaid debt, and in order to secure the payment thereof and of any other and further sums for which the Mortgagor may be indebted to the Mortgagee at any time for advances made to or for his account by the Mortgagee, and also in consideration of the further sum of Three Dollars (\$3.00) to the Mortgagor in hand well and truly paid by the Mortgagee at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold and released, and by these presents does grant, bargain, sell and release unto the Mortgagee, its successors and assigns:

"All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, in Oaklawn Township, containing one acres, more or less, adjoining lands of Alvin Davis, C. H. Bennett, James Martin, T. H. Martin and others and being on the Eastern side of State Highway No. 29, and having the following courses and distances to wit:-

"BEGINNING at a point in the center of the Old Greenville Road and running thence N. 36 1/2 W. 1 chain, 41 links to the line of Alvin Davis; thence along the line of Alvin Davis, S. 39 1/4 W. 0.50 to an angle; thence S. 57 1/2 W. 0.50 to an angle; thence S. 75 1/2 W. 1.53 to the center of Highway No. 29; thence along the center of Highway No. 29, S. 4 W. 4.00 to intersection of the Old Greenville Road; thence along the Old Greenville Road, N. 38 1/2 E. 5.24 to the beginning corner."
