on the east side of Watson Street in the City of Greenville known as lot number 10 on a plat of the Watson property. Said plat is recorded in the office of the R. M. C., Greenville County in book G, page 164. This is the same lot conveyed to Onie Elizabeth Harmon by W. G. Serrine by deed dated November 1, 1938, said deed is recorded in the office of the R. M. C., Greenville County in book 207, page 67. The land is specifically described by courses and distances as follows:

Beginning at the joint corners of lots numbers 9 and 10 on a plat above referred to at a point 51 feet southwest of Grace Street and running thence along Watson Street S. 18-40 E. 51 feet to joint corners of lots 10 and 11 and along joint lines of lot number 10 and 11 N. 71-06 E. 117.2 feet to corner; thence N. 17-55 W. 51 feet to lot number 9 along joint line of lots numbers 9 and 10; thence S. 71-04 W. 118 feet to the beginning corner on Watson Street.
