all that tract or lot of land in Greenville, Township, Greenville County, State of South Carolina.

in the City of Greenville on the east side of Watson Street and being known and designated as lot number 10 of a plat recorded in the R.M.C. Office, Greenville County in book G, page 164. It begins at the corner of lots numbers 9 and 10 on the said plat a distance of 51 feet southwest from Grace Street and runs thence along Watson Street S. 18-40 W. 51 feet to corner of lot number 11; thence along joint line of lot number 10 and 11 N. 71-04 E. 117.2 feet to joint corner of lots numbers 6, 7, 10 and 11; thence along joint line of lots numbers 7 and 10 N. 17-55 W. 51 feet to corner of lot number 9; thence along joint line of lots numbers 9 and 10 S. 71-04 W. 110 feet to the beginning corner on Watson Street.
