P. Williamson

all that tract or lot of land in Greenville Township, Greenville County, State of South Carolina.

in the City of Greenville, being in Ward 6 of said city, and being known and designated as Lot No. 6 on plat of subdivision of lands, said subdivision of land being bounded by Houstonia Street, Plum Street, lands now or formerly of Fannie Lewis, and the Columbia and Greenville Railroad, and being a part of a tract of land conveyed to St. John Cox by deed from Mary E. Cox dated May 26, 1886, recorded in R.M.C. Office for Greenville County in Deed Book 88, page 845, and having according to said deed the following metes and bounds, to-wit:-

BEGINNING at a stake in west side of Roberson Street and corner of Lot No. 8 and running thence N. 12 E. 60 feet with Roberson Street to a stake corner of Lot No. 4; thence with line of Lots 4 and 3, N. 78 W. 100 feet to a stake corner of Lots 2, 5, 5, and 6; thence with line of Lot No. 5, S. 12 W. 60 feet to a stake corner of Lots Nos. 5, 6, 7 and 8; thence with line of Lot No. 8, S. 78 E. 100 feet to point of beginning.

The above described property is the same conveyed to J. Duff Thompson by Hannah J. Cox, et al, by deed dated November 5, 1891, recorded in R.M.C. Office for Greenville County, in Deed Book XX, page 894, and the same conveyed to Bowman Wilson by deed from J. Duff Thompson on the same date as this mortgage, deed to be recorded.

It is expressly understood and agreed that this mortgage is junior in lien to a certain mortgage in the amount of eighteen hundred dollars dated August 13, 1946, by Bowman Wilson to B. S. Hodges.
