MORTGAGE

TO ALL WHOM THESE PRESENTS MAY CONCERN: We, Frank C. Foster and Billie M. Foster  
(hereinafter referred to as Mortgagor) SEND(S) GREETING:

WHEREAS, the Mortgagor is well and truly indebted unto FIDELITY FEDERAL SAVINGS AND LOAN ASSOCIATION, GREENVILLE, S. C., (hereinafter referred to as Mortgagee) as evidenced by the Mortgagor's promissory note of even date herewith, the terms of which are incorporated herein by reference in the sum of Seventy-seven Hundred Fifty and No/100 - - - - -

"All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, Greenville Township, on the South side of Aberdeen Drive, near the City of Greenville, known and designated as Lot No. 6 on Plat of Park Hill Terrace, recorded in the R.M.C. Office for Greenville County, S. C., in Plat Book J at Page 163, and having, according to said Plat, the following metes and bounds, to-wit:-

"BEGINNING at an iron pin on the South side of Aberdeen Drive, joint corner of Lots Nos. 5 and 6, and running thence with the line of Lot No. 5, S. 19-58 W. 146.6 feet to an iron pin thence S. 69-38 E. 65 feet to an iron pin; thence with the line of Lot No. 7, N. 22-57 E. 145.6 feet to an iron pin on the South side of Aberdeen Drive; thence with the South side of Aberdeen Drive, N. 69-02 W. 70 feet to the beginning corner."

Said premises being the same conveyed to Billie M. Foster by A. Newton Stall by deed dated Jan. 17, 1946, recorded in Book of Deeds 285 at Page 324; she having conveyed one-half interest in said premises to Frank C. Foster by deed of even date to be recorded herewith.
