MORTGAGE

TO ALL WHOM THESE PRESENTS MAY CONCERN: I, Annie V. Green

(hereinafter referred to as Mortgagor) SEND(S) GREETING:

WHEREAS, the Mortgagor is well and truly indebted unto FIDELITY FEDERAL SAVINGS AND LOAN ASSOCIATION, GREENVILLE, S. C., (hereinafter referred to as Mortgagee) as evidenced by the Mortgagor's promissory note of even date herewith, the terms of which are incorporated herein by reference in the sum of Twelve Hundred & No/100 - - - - -

DOLLARS (\$1,200.00), with interest thereon from date at the rate of six (6%) per centum per annum, said principal and interest to be repaid as therein stated, and

"All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, in Greenville Township, on the Southern side of Rose Street (formerly Rhodes Street), near the City of Greenville, being shown as Lot No. 15 on plat of property of Corinne Bates made by W. J. Riddle on May 4, 1937, recorded in Plat Book "I" at Page 126, and described as follows:

"BEGINNING at a stake on the Southern side of Rose Street, corner of Lot No. 16, and running thence with the line of said lot, S. 28-23 W. 212 feet to a stake at corner of Lot No. 31; thence with the line of said lot, N. 61-37 E. 60 feet to a stake; thence N. 28-23 E. 212 feet to a stake on Rose Street; thence with the Southern side of Rose Street, S. 61-37 W. 60 feet to the beginning corner."

Said premises being the same conveyed to the mortgagor by Corinne Bates be deed dated January 3, 1940, recorded in Book of Deeds 217 at page 110.
