WHEREAS, the Mortgagor is well and truly indebted unto FIDELITY FEDERAL SAVINGS AND LOAN ASSOCIATION, GREENVILLE, S. "All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, in Greenville Township, known and designated as Lot No. 57 and the Southern 12½ feet of Lot No. 58, of Lanneau Drive Highlands, according to plat made by Dalton & Neves, Engrs., August 1937, recorded in R.M.C. Office for Greenville County in Plat Book "D", at pages 288-289, and having the following metes and bounds:

BEGINNING at a point on the Western side of Lanneau Drive, joint eastern corner of Lots 56 & 57 and running thence with the western side of Lanneau Drive N. 10-11 E. 62½ feet to pin; thence N. 79-49 W. 150 feet to a point on line of Donaldson property; thence S. 10-11 W. 62½ feet to corner of Lot No. 56; thence S. 79-49 W. 150 feet to point of beginning; being the same property conveyed to the mortgagors by O.
