MORTGAGE

TO ALL WHOM THESE PRESENTS MAY CONCERN: I, Edward O. McKenzie
.....(hereinafter referred to as Mortgagor) SEND(S) GREETING:

WHEREAS, the Mortgagor is well and truly indebted unto FIDELITY FEDERAL SAVINGS AND LOAN ASSOCIATION, GREENVILLE, S. C., (hereinafter referred to as Mortgagee) as evidenced by the Mortgagor's promissory note of even date herewith, the terms of which are incorporated herein by reference in the sum of Forty-Two Hundred and No/100 DOLLARS (\$4,200.00), with interest thereon from date at the rate of four (4%) per centum per annum, said principal and interest to be repaid as therein stated, and

"All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, in Greenville Township, known and designated as Lot No. 15 of Block L of Highland, a subdivision of land of H. K. Townes, as represented by a plat recorded in the R.M.C. Office for Greenville County in Plat Book K at Pages 50 and 51, and being more particularly described, according to said plat, as follows:

"BEGINNING at an iron pin on Florida Avenue, joint corner of Lots Nos. 14 and 15, and running thence S. 89-45 E. 163.5 feet to an iron pin in line of the right of way of the Piedmont and Northern Railway Company; thence S. 9-15 E. 60.9 feet to an iron pin in line of Lot No. 16; thence with the line of Lot No. 16, N. 89-45 W. 173.6 feet to an iron pin on Florida Avenue; thence with said Florida Avenue, N. 12-30 W. 60 feet to the beginning corner."

Said premises being the same conveyed to Edward O. McKenzie and Mary L. McKenzie by Robert Lee Robbins by deed dated May 31, 1946, recorded in Volume 292 at Page 255; the half interest of the said Mary L. McKenzie being conveyed to the mortgagor by deed to be recorded herewith.
