TO ALL WHOM THESE PRESENTS MAY CONCERN: I, John P. Taylor
.....(hereinafter referred to as Mortgagor) SEND(S) GREETING:

WHEREAS, the Mortgagor is well and truly indebted unto FIDELITY FEDERAL SAVINGS AND LOAN ASSOCIATION, GREENVILLE, S. C., (hereinafter referred to as Mortgagee) as evidenced by the Mortgagor's promissory note of even date herewith, the terms of which are incorporated herein by reference in the sum of Four Thousand and No/100 -----

"All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, Greenville Township, at the northwestern corner of the intersection of Franklin Road and Douglas Avenue and being shown as Lots Nos. 70 and 71 on plat recorded in Plat Book "G" at Page 112 and having, according to said plat the following metes and bounds, to-wit:-

BEGINNING at an iron pin at the northwestern corner of the intersection of Franklin Road and Douglas Avenue and running thence with the western side of Douglas Avenue N. 24-02 W. 350 feet to an iron pin, S. 46-03 W. 120 feet to iron pin corner of Lot No. 69; thence with line of Lot No.69 S. 44-02 E. 350 feet to iron pin on Franklin Road; thence with North side of Franklin Road N. 46-03 E. 120 feet to point of beginning.
