All those two certain lots of land in the County and State aforesaid, facing on Hillcrest Drive, with Hillcrest Circle forming a side line of one lot and being known and designated as lots numbers 4 and 5 on a plat of "Hillcrest Circle", as recorded in Plat Book H, page 129 in the office of the R.M.C., Greenville County, S. C. separately described the lots are as follows:-  
Lot number 4 begins on the north side of Hillcrest Drive at the west side of Hillcrest Circle and runs along the west side of Hillcrest Circle N. 26-30 E. 164 feet to lot number 21; thence by joint line of lots numbers 4 and 21 N. 79-08 W. 80 feet to corner on lot number 5; thence S. 29-37 W. along joint line lots numbers 4 and 5 a distance of 157.8 feet to corner on west side of Hillcrest Drive; thence along the north side of Hillcrest Drive S. 68-54 E. 52 feet to beginning.  
Lot Number 5 begins on the north side of Hillcrest Drive at corner of lot number 4 and runs along the joint line of lots numbers 4 and 5 N. 29-37 E. 157.8 feet to corner of lot number 21; thence along joint line of lots numbers 5 and 21 N. 62-24 W. 40 feet to lot number 6; thence along the joint line of lots numbers 5 and 6 S. 34-40 W. 152 feet to corner on the north side of Hillcrest Drive; thence along the north side of Hillcrest Drive S. 54-54 E. 52 feet to the beginning corner.
