MORTGAGE

TO ALL WHOM THESE PRESENTS MAY CONCERN: I, Grady Wheatley

(hereinafter referred to as Mortgagor) SEND(S) GREETING:

WHEREAS, the Mortgagor is well and truly indebted unto FIDELITY FEDERAL SAVINGS AND LOAN ASSOCIATION, GREENVILLE, S. C., (hereinafter referred to as Mortgagee) as evidenced by the Mortgagor's promissory note of even date herewith, the terms of which are incorporated herein by reference in the sum of Three Thousand and No/100

DOLLARS (\$3000.00), with interest thereon from date at the rate of six (6%) per centum per annum, said principal and interest to be repaid as therein stated, and

WHEREAS, the Mortgagor may hereafter become indebted to the said Mortgagee for such further sums as may be advanced to or for the Mortgagor's account for taxes, insurance premiums, public assessments, repairs, or for any other purpose;

NOW, KNOW ALL MEN, That the Mortgagor, in consideration of the aforesaid debt, and in order to secure the payment thereof and of any other and further sums for which the Mortgagor may be indebted to the Mortgagee at any time for advances made to or for his account by the Mortgagee, and also in consideration of the further sum of Three Dollars (\$3.00) to the Mortgagor in hand well and truly paid by the Mortgagee at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold and released, and by these presents does grant, bargain, sell and release unto the Mortgagee, its successors and assigns:

"All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, in Butler Township, on the Southern side of Lee Road near the City of Greenville, being shown as Lots Nos. 206, 207, 208, 209 and 210 in Butler Township, on plat of property of the Gattino heirs, made by W.A. Bunn in August 1939, recorded in Plat, Book "J" at Page 121 and described as follows:

BEGINNING at a stake on the Southern side of Lee Road 129.2 feet South from a 30 foot Street at corner of Lot No. 211 and running thence with line of said lot S. 8-27 W. 356.5 feet to a stake in line of Lot No. 143; thence with line of Lots 143 and 146 S. 74-30 E. 127.1 feet to a stake at corner of Lot No. 205; thence with line of said lot N. 9-25 E. 356 feet to a stake on the Southern side of Lee Road; thence with the South side of Lee Road 132.2 feet to the beginning corner.

Said premises being the same conveyed to the mortgagor by two deeds, one by P. F. Cuttino dated April 1946, recorded in Book of Deeds 294 at page 202 and the other by H. P. Cuttino dated May 6, 1946, recorded in Book of Deeds 294 at Page 204.
