"All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, in Greenville Township, on the Northern side of Marion Road, near the City of Greenville,

being a portion of Lot No. 120 as shown on Plat of City View Annex, recorded in Plat Book "G" at page 154, and described as follows:-

BEGINNING at a stake on the Northern side of Marion Road at corner of Lot No. 121, and running thence with the line of said lot N. 29-30 W. 246 feet to a stake on a branch; thence with said branch in a northerly direction 90 feet to a stake, corner of property of Joseph M.
