To All Whom These Presents May Concern:

I, Lee West, SEND GREETING:

WHEREAS, I the said Lee West,

in and by my certain promissory note in writing of even date with these Presents, am well and truly indebted unto the CITIZENS BUILDING AND LOAN ASSOCIATION, Greer, S. C., in the full and just sum of One Thousand & 00/100 - - - - - (\$ 1000.00 ) Dollars, with interest from the date hereof at the rate of seven per cent ( 7 %) per annum, unpaid interest to bear interest at the same rate, to be repaid in installments of - - - - - Sixteen & 00/100 - - - - - (\$ 16.00 ) dollars

due and payable on the 5th day of each and every calendar month hereafter until the full principal sum, with interest and all costs, insurance, and expenses incurred in connection with said loan, has been paid, said monthly payments to be applied first to the payment of interest, and then to payment of principal, costs, expenses and insurance, if any, incurred; and said note further providing that if at any time any portion of the principal or interest due hereunder shall be past due and unpaid for a period of sixty (60) days, or upon failure to comply with any of the by-laws of said Association, or with any of the stipulations of this mortgage, the whole amount due under said note, shall at the option of the holder become immediately due and payable, and said note further providing for a reasonable attorney's fee besides all costs and expenses of collection, to be added to the amount due on said note, and collectible as a part thereof, if the same be placed with an attorney for collection, or if said debt, or any part thereof, be collected by an attorney or by legal proceedings of any kind.

C., according to the terms of the said note, and also in consideration of the further sum of Three (\$3.00) Dollars to me the said mortgagor, in which well and truly paid by the said mortgagee, at and before the sealing and delivery of these Presents (receipt of which is hereby acknowledged), have granted, bargained, sold and released, and by these Presents do grant, bargain, sell and release unto the said CITIZENS BUILDING AND LOAN ASSOCIATION, Greer, S. C., its successors and assigns:

That certain lot, parcel or tract of land, with all improvements now constructed thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, in O'Neal Township, near Ansel Schoolhouse, and having the following metes and bounds, to-wit:-

BEGINNING at an iron pin in the center of the CCC Camp to Taylors Orchard Road, better known as the Old Ballenger Road, and running thence S. 47-00 W. 920 feet to an iron pin in the center of said Road on the bank of Frohawk Creek; thence S. 28-10 E. 80.5 feet to a water oak (OM) on the bank of said Frohawk Creek; thence N. 58-15 E. 790 feet to a stake(iron pin); thence N. 7-45 W. 288 feet to the beginning corner, an iron pin in the center of the Old Ballenger Road, and containing Three and 19/100 (3.19) acres, more or less, and being the same property conveyed to me by Rosa West by deed dated August 20, 1938 and recorded in R.M.C.
