MORTGAGE

TO ALL WHOM THESE PRESENTS MAY CONCERN: We, Lorene Payne and Mrs. R. A. Payne
(hereinafter referred to as Mortgagor) SEND(S) GREETING:

WHEREAS, the Mortgagor is well and truly indebted unto FIDELITY FEDERAL SAVINGS AND LOAN ASSOCIATION, GREENVILLE, S. C., (hereinafter referred to as Mortgagee) as evidenced by the Mortgagor's promissory note of even date herewith, the terms of which are incorporated herein by reference in the sum of Three Thousand Four Hundred Fifty and No/100 DOLLARS (\$3,450.00), with interest thereon from date at the rate of five and one-half per centum per annum, said principal and interest to be repaid as therein stated, and

"All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, in Greenville Township, being known and designated as Lot No. 9, as shown on Plat of East Augusta Place recorded in Plat Book F, at page 128, and being more particularly described as follows:

BEGINNING at an iron pin, joint front corner of Lots Nos. 8 and 9, and running thence N. 26-30 W. 249.8 feet to an iron pin, joint rear corner of Lots Nos. 8 and 9; thence N. 63-30 E. 60 feet to an iron pin, joint rear corner of Lots Nos. 9 and 10; thence S. 26-30 E. 244.4 feet to an iron pin in Augusta Place, joint front corner of Lots Nos. 9 and 10; thence with Augusta Place, S. 58-30 W. 60.23 feet to the beginning corner.
