WHEREAS, the Mortgagor is well and truly indebted unto FIDELITY FEDERAL SAVINGS AND LOAN ASSOCIATION, GREENVILLE, S. C., (hereinafter referred to as Mortgagee) as evidenced by the Mortgagor's promissory note of even date herewith, the terms of which are incorporated herein by reference in the sum of Forty-Five Hundred and No/100 -----

"All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, in Chick Springs Township, on the South side of Piney Mountain Road and being known as the Northern part of Lot 19 and the Northern one-half of Lot 20, on the plat of property of Paris-Piney Park, surveyed by C. M. Furman, Jr., Engineer, June 1926, and described as follows:

BEGINNING at an iron pin on the Southern side of Piney Mountain Road at the joint front corner of Lots 19 and 18 and running thence with line of Lot 18, S. 34-30 W. 107.5 feet to iron pin; thence N. 55-30 E. 75 feet to an iron pin, which is the center point of Lot No. 20; thence N. 34-30 E. 107.5 feet to iron pin on Southern side of Piney Mountain Road; thence with Southern side of Piney Mountain Road, N. 57-14 W. 75 feet to the point of beginning.

Said premises being the Western half of the property conveyed to the mortgagor by W. J. Kelly by deed dated September 16th, 1946, recorded in Volume 300 at page 187.
