The South Carolina National Bank of Charleston, its Successors and Assigns, forever:-

All that piece, parcel or lot of land in Greenville Township, Greenville County, State of  
South Carolina, and being known and designated as Lot #13, Block "F", on the revised plat on the  
subdivision known as Kanatenah, which plat is recorded in the R.M.C. Office in Plat Book "F",  
page 131, and being one of the lots conveyed to A. Y. Willis by F. A. Lawton by his deed dated the  
17th day of May, 1923 and recorded in the R.M.C. Office for Greenville County, S. C., in Deed  
Book Vol. 90, at page 27. The lot herein conveyed is more particularly described as follows:

BEGINNING at a pin on the North side of Cureton Street at joint corner of lots 12 and 13  
as shown on the plat hereinabove referred to and running thence along the line of Lot 12, N. 25-51  
W. 160 feet to the rear joint corner of Lots Nos. 12, 13, 26 and 27; thence along the rear line of  
Lots Nos. 13 and 27, N. 63-35 E. 60 feet to the joint corner of Lots 27, 28, 13 and 14; thence  
along the line of Lot No. 14, S. 25-51 E. 155 feet to a point on Cureton Street at or near the  
intersection of Cureton and Mitchell Streets; thence with the line of Cureton Street 60 feet to  
the beginning point.
