Whereas, I the said Eston H. Huntsinger

All that piece, parcel or lot of land in Glassy Mountain Township, Greenville County, South Carolina,

BEGINNING at a stake in the center of the road which leads from Tryon by the Piedmont Council Boy Scout Camp and beyond which stake bears North 30 degrees West 20 feet from a pine tree which is a corner of the Lake Lanier Property and the Warren Fisher property and runs from said stake with the Lake Lanier property line North 30 degrees West 211 feet to a stake; thence still with the Lake Lanier property line North 403 feet to a stake in John W. Lankford's line; thence with John W. Lankford, Floyd Blackwell and Ester Sue Durham; thence with the Floyd Blackwell line South 3 degrees East 380 feet to a stake in the center of the road; thence with the road which is also the Bill Fisher line 6 calls as follows:

South 41-1/4 degrees East 50 feet; South 26-1/2 deg. East 90 feet; South 73-1/2 deg. East 200 feet; South 60 deg. East 150 feet; South 73-1/2 deg. East 200 feet; North 70 deg. East 186 feet to the beginning. Containing 8-1/2 acres, more or less.
