WHEREAS, the Mortgagor is well and truly indebted unto FIDELITY FEDERAL SAVINGS AND LOAN ASSOCIATION, GREENVILLE, S. NOW, KNOW ALL MEN, That the Mortgagor, in consideration of the aforesaid debt, and in order to secure the payment thereof and of any other and further sums for which the Mortgagor may be indebted to the Mortgagee at any time for advances made to or for his account by the Mortgagee, and also in consideration of the further sum of Three Dollars (\$3.00) to the Mortgagor in hand well and truly paid by the Mortgagee at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold and released, and by these presents does grant, bargain, sell and release unto the Mortgagee, its successors and assigns:

"All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, in Greenville Township, near the City of Greenville, known and designated as Lot No. 69 in Block D of the Subdivision known as Augusta Court, as shown on a Plat of record in the R.M.C. Office for Greenville County in Plat Book "F" at Page 124, and having, according to said Plat, the following metes and bounds, to-wit:-

"BEGINNING at an iron pin on the Northwest side of Augusta Court, joint corner of Lots Nos. 69 and 70, and running thence with the joint lines of said lots, N. 39-24 W. 160.4 feet to an iron pin, joint corner of Lots Nos. 57 and 69; thence with the joint lines of said lots, S. 51-20 W. 69.83 feet to an iron pin, joint corner of Lots Nos. 68 and 69; thence with the joint lines of said lots, S. 39-22 E. 164.8 feet to an iron pin on Augusta Court; thence with Augusta Court, N. 47-10 E. 60 feet to the point of beginning."
