"All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, in Greenville Township, on the Western side of Underwood Avenue, in the Subdivision known as Glenn Grove Park, known and designated as Lot #54 on Plat recorded in R.M.C. Office

in Plat Book F, Page 233, and having according to said plat the following metes and bounds, to-wit:

BEGINNING at an iron pin on the Western side of Underwood Avenue at rear corner of Lot #55, and running thence with the rear of lots Nos. 55, 56 and 57, N. 74-12 W. 150 feet to corner of Lot #61; thence with the rear line of Lot #61, S. 15-48 W. 50 feet to the corner of Lot #53; thence with the line of said lot, S. 74-12 E. 150 feet to iron pin on Underwood Avenue; thence with Western side of Underwood Avenue, N. 15-48 E. 50 feet to the beginning corner.
