MORTGAGE

TO ALL WHOM THESE PRESENTS MAY CONCERN: I, Lizrie S. Rhodes
(hereinafter referred to as Mortgagor) SEND(S) GREETING:

WHEREAS, the Mortgagor is well and truly indebted unto FIDELITY FEDERAL SAVINGS AND LOAN ASSOCIATION, GREENVILLE, S. C., (hereinafter referred to as Mortgagee) as evidenced by the Mortgagor's promissory note of even date herewith, the terms of which are incorporated herein by reference in the sum of Twenty-Two Hundred and No/100 DOLLARS (\$ 2200.00), with interest thereon from date at the rate of Six (6%) per centum per annum, said principal and interest to be repaid as therein stated, and

"All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, in Greenville Township, being known and designated as Lot #8 as shown on plat of Dunean Heights recorded in Plat Book "D" , at Page 67 and more particularly described, according to said plat, as follows:-

BEGINNING at an iron pin on the South side of Hillhouse Street, joint corner of Lots #7 and 8 and running thence with joint line of said lots, S. 35-45 E. 120 feet to an iron pin; thence N. 54-15 W. 60 feet to an iron pin in line of Lot #9; thence with joint line of Lots #8 and 9, N. 35-45 E. 120 feet to an iron pin on South side of Hillhouse Street; thence with Hillhouse Street S. 54-15 E. 60 feet to the beginning corner. Being the same premises conveyed to the mortgagor by C. S. Fox by deed dated April 1, 1946, recorded in Volume 290 , at Page 119.
