"All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, in Greenville Township, on the southern side of West Tallulah Drive, being shown as lot #13 on plat of property of H.L.S. Investment Company made by Dalton & Neves in May 1937, recorded in Plat Book D, at Page 225, and described as follows:

BEGINNING at a stake on the southern side of West Tallulah Drive 655 feet west from Augusta Road at corner of lot #12, and running thence with line of said lot, S. 34-10 E. 196 feet to a stake; thence S. 55-50 W. 65 feet to a stake, ~~corner lot #13, S. 34-10 E. 100 feet to a stake; thence S. 55-50 W. 65 feet to a stake,~~ corner of lot #14; thence with the line of said lot, N. 34-10 W. 196.4 feet to a stake on the southern side of West Tallulah Drive; thence with the southern side of West Tallulah Drive, N. 55-50 E. 65 feet to the beginning corner; being the same property conveyed to H. E. Langston by H. L. Investment Company by deed dated February 18, 1939, recorded in Book of Deeds 209 at Page 58.
