MORTGAGE

TO ALL WHOM THESE PRESENTS MAY CONCERN: I, Hazel Childs

(hereinafter referred to as Mortgagor) SEND(S) GREETING:

WHEREAS, the Mortgagor is well and truly indebted unto FIDELITY FEDERAL SAVINGS AND LOAN ASSOCIATION, GREENVILLE, S. C., (hereinafter referred to as Mortgagee) as evidenced by the Mortgagor's promissory note of even date herewith, the terms of which are incorporated herein by reference in the sum of

NOW, KNOW ALL MEN, That the Mortgagor, in consideration of the aforesaid debt, and in order to secure the payment thereof and of any other and further sums for which the Mortgagor may be indebted to the Mortgagee at any time for advances made to or for his account by the Mortgagee, and also in consideration of the further sum of Three Dollars (\$3.00) to the Mortgagor in hand well and truly paid by the Mortgagee at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold and released, and by these presents does grant, bargain, sell and release unto the Mortgagee, its successors and assigns:

"All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, Greenville Township, on the Western side of Mace Street, near the City of Greenville being the northern portion of Lot No. 30, as shown on Plat of Eastover, made by R.E. Dalton, Eng., in July 1920, recorded in Plat Book F at Page 42, and described as follows:

"BEGINNING at an iron pin on Mace Street, joint corner of Lots Nos. 29 and 30, and running thence with Mace Street, S. 36-10 E. 54 feet to an iron pin; thence S. 53-50 W. 119.91 feet to an iron pin; thence N. 37-01 W. 54 feet to an iron pin; thence N. 53-50 E. 120.3 feet to beginning; being the same premises conveyed to the Mortgagor by Marlin V. Perry and Willie B. Perry, by deed dated April 6, 1945, recorded in Book of Deeds 274 at Page 127."
