on the South side of Rutherford Road and having the following metes and bounds, to-wit:-

BEGINNING at a point on said Rutherford Road, joint corner of lots Nos. 8 and 9, as shown on plat recorded in the office of Register Mesne Conveyance in and for Greenville County in Plat Book E at Page 219, and running thence with Rutherford Road S. 28-30 W. 75 feet to joint corner of lots 5 and 6, said plat; thence with joint line of said lots 5 and 6 S. 66-00 E. 71 feet to a point on a 20 foot alley; thence N. 20-00 E. 75 feet to a point in line of said lot No. 9; thence with joint line lots 8 and 9 N. 66-00 W. 60.5 feet to the point of beginning on Rutherford Road, and being the front part of lots Nos. 6, 7 and 8, said plat.

ALSO, an undivided right, interest and easement in and to the 20-foot alley or driveway lying immediately back of the premises herein above described, and as shown on plat of W. J.
