All that piece, parcel or lot of land in Greenville Township, Greenville County,
State of South Carolina, on the north side of Perry Road being known and designated as Lot
No. 2 on Plat of property of Ethel Y. Perry Estate, prepared by W. J. Riddle, Surveyor,
