"All that eertain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County in Greenville Township, on the East side of Maynsworth Road, near the City of Greenville being shown as lots #5, 6, 7 and 18 on a Second Revised Plat of Farr Estates made by W. J.
