CENTRAL HANOVER BANK AND TRUST COMPANY, a corporation organized and existing under the laws of the State of New York, herein acting as Trustee under First Mortgage of The Atlanta and Charlotte Air Line Railway Company, dated November 1, 1943 (recorded, among other places, in the the office of the Register of Mesne Conveyance for Greenville County, South Carolina, in Book 324, page 1, January 7, 1944) hereinafter for convenience styled TRUSTEE, party of the first part ; and

THE ATLANTA AND CHARLOTTE AIR LINE RAILWAY COMPANY, a consolidated corporation organized and existing under the laws of the States of Georgia, South Carolina and North Carolina, party of the second part;

W I T N E S S E T H: That
