TO ALL WHOM THESE PRESENTS MAY CONCERN: We, H. S. Collison, Jr. and June W. Collison

(hereinafter referred to as Mortgagor) SEND(S) GREETING:

WHEREAS, the Mortgagor is well and truly indebted unto FIDELITY FEDERAL SAVINGS AND LOAN ASSOCIATION, GREENVILLE, S. C., (hereinafter referred to as Mortgagee) as evidenced by the Mortgagor's promissory note of even date herewith, the terms of which are incorporated herein by reference in the sum of-----

Four Thousand and No/100 -----

DOLLARS (\$ 4,000.00 -----), with interest thereon from date at the rate of Five (5%) ----- per centum per annum, said principal and interest to be repaid as therein stated, and

NOW, KNOW ALL MEN, That the Mortgagor, in consideration of the aforesaid debt, and in order to secure the payment thereof and of any other and further sums for which the Mortgagor may be indebted to the Mortgagee at any time for advances made to or for his account by the Mortgagee, and also in consideration of the further sum of Three Dollars (\$3.00) to the Mortgagor in hand well and truly paid by the Mortgagee at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold and released, and by these presents does grant, bargain, sell and release unto the Mortgagee, its successors and assigns:

"All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, in Greenville Township, situate on the North side of Crystal Avenue, being known and designated as lot #2 on a plot of the property of the J. Milton Williams Estate made by W. J. Riddle on July 18, 1947, and more particularly described as follows:

"BEGINNING at an iron pin on the North side of Crystal Avenue which iron pin is located 300 feet from the Northwest corner of Crystal Avenue and Augusta Road and runs thence N. 29-18 W. 100 feet to an iron pin; thence S. 60-42 W. 50 feet to an iron pin; thence S. 29-18 E. 100 feet to an iron pin located on Crystal Avenue; thence along Crystal Avenue N. 60-42 E. 50 feet to the point of beginning."

An undivided one-half interest in the foregoing premises was devised to June W. Collison by J. Milton Williams, the other undivided one-half interest was devised to J. Milton Williams, Jr. who has conveyed the same to H. S. Collinson, Jr. by deed dated August 8, 1947, to be recorded.
