NOW, KNOW ALL MEN, That the Mortgagor, in consideration of the aforesaid debt, and in order to secure the payment thereof and of any other and further sums for which the Mortgagor may be indebted to the Mortgagee at any time for advances made to or for his account by the Mortgagee, and also in consideration of the further sum of Three Dollars (\$3.00) to the Mortgagor in hand well and truly paid by the Mortgagee at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold and released, and by these presents does grant, bargain, sell and release unto the Mortgagee, its successors and assigns:

"All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, in Greenville Township, on the Southwest side of Oscar Street in the City of Greenville, being shown as all of Lot No. 5 and the Western half of Lot No. 4 on plat of the property of T. Oregon Lawton, Jr., recorded in the R.M.C. Office for Greenville County in Plat Book "A" at Page 435, and being more particularly described

"BEGINNING at a stake on the Southwest side of Oscar Street, 105 feet West from Bailey Street, and running thence through the center of Lot No. 4, S. 30-00 W. 125 feet to a stake; thence N. 54-15 W. 45 feet to a stake; thence N. 30-00 E. 125 feet to a stake on Oscar Street; thence with the Southwest side of Oscar Street, S. 54-15 E. 45 feet to the point of beginning."
