TO ALL WHOM THESE PRESENTS MAY CONCERN: I, Fred N. Henson

(hereinafter referred to as Mortgagor) SEND(S) GREETING:

WHEREAS, the Mortgagor is well and truly indebted unto FIDELITY FEDERAL SAVINGS AND LOAN ASSOCIATION, GREENVILLE, S. NOW, KNOW ALL MEN, That the Mortgagor, in consideration of the aforesaid debt, and in order to secure the payment thereof and of any other and further sums for which the Mortgagor may be indebted to the Mortgagee at any time for advances made to or for his account by the Mortgagee, and also in consideration of the further sum of Three Dollars (\$3.00) to the Mortgagor in hand well and truly paid by the Mortgagee at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold and released, and by these presents does grant, bargain, sell and release unto the Mortgagee, its successors and assigns:

"All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, in Greenville Township, on the southern side of Arlington Avenue in the City of Greenville and described as follows:

"BEGINNING at a stake at the Southeast corner of Arlington Avenue at a 10-foot alley and running thence with the Eastern side of said alley in a Southerly direction 138.5 feet to a stake; thence in an Easterly direction 50 feet to a stake; thence in a Northerly direction 137.28 feet to a stake on the South side of Arlington Avenue; thence with the Southern side of Arlington Avenue in an Easterly direction 50 feet to the beginning corner.
