due and payable in monthly installments of \$30.00 each the first such installment becoming due November 3rd, 1947, and a like installment to become due on the same day of each and every month thereafter until the whole sum has been paid in full. Interest to be paid quarterly in addition to said payments. The mortgagor hereof reserves the right to pay all or any part due hereon at any installment paying date hereafter.

with interest thereon from date at the rate of six per centum per annum, to be computed and paid quarterly until paid in full; all
