MORTGAGE

TO ALL WHOM THESE PRESENTS MAY CONCERN: We, J. P. Harrison and Esther P. Harrison

(hereinafter referred to as Mortgagor) SEND(S) GREETING:

WHEREAS, the Mortgagor is well and truly indebted unto FIDELITY FEDERAL SAVINGS AND LOAN ASSOCIATION, GREENVILLE, S. C., (hereinafter referred to as Mortgagee) as evidenced by the Mortgagor's promissory note of even date herewith, the terms of which are incorporated herein by reference in the sum of Twenty-Seven Hundred and No/100 - - - - -

DOLLARS (\$ 2700.00), with interest thereon from date at the rate of Six (6%) per centum per annum, said principal and interest to be repaid as therein stated, and

WHEREAS, the Mortgagor may hereafter become indebted to the said Mortgagee for such further sums as may be advanced to or for the Mortgagor's account for taxes, insurance premiums, public assessments, repairs, or for any other purpose;

NOW, KNOW ALL MEN, That the Mortgagor, in consideration of the aforesaid debt, and in order to secure the payment thereof and of any other and further sums for which the Mortgagor may be indebted to the Mortgagee at any time for advances made to or for his account by the Mortgagee, and also in consideration of the further sum of Three Dollars (\$3.00) to the Mortgagor in hand well and truly paid by the Mortgagee at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold and released, and by these presents does grant, bargain, sell and release unto the Mortgagee, its successors and assigns:

"All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, in Greenville Township, and being known and designated as lot No. 6 and one-half of lot No. 7 as shown on Plat of Langley Heights recorded in the R.M.C. office for Greenville County, in Plat Book I at Page 77, and being more particularly described, according to said plat, as follows:-

"BEGINNING at a stake on the Southwestern side of Edgewood Drive (formerly Owens Street), 192 feet Northwest from Grove Road in the center of lot No. 7, and running thence S. 49-47 W. 200 feet to a stake; thence N. 40-13 W. 75 feet to a stake, corner of lot No. 5; thence with the line of said lot, N. 49-47 E. 200 feet to a stake on Edgewood Drive (formerly Owens Street); thence with the Southwestern side of Edgewood Drive, S. 40-13 E. 75 feet to the beginning corner."

Said premises being the same conveyed to the mortgagors herein by R. J. Correll by deed dated September 24, 1941, recorded in Volume 237 at Page 331.
