I, Bernyrd C. McLawhorn,

hereinafter spoken of as the Mortgagor send greeting.

Whereas I, Bernyrd C. McLawhorn, am

justly indebted to C. Douglas Wilson & Co., a corporation organized and existing under the laws of the State of South Carolina, hereinafter spoken of as the Mortgagee, in the sum of Twelve-Thousand & No/1 00 - - - - - Dollars

(\$ 12,000.00 - - - - -), lawful money of the United States which shall be legal tender in payment of all debts and dues, public and private, at the time of payment, secured to be paid by that one certain bond or obligation, bearing even date herewith, conditioned for payment at the principal office of the said C. Douglas Wilson & Co., in the City of Greenville, S. C., or at such other place either within or without the State of South Carolina, as the owner of this obligation may from time to time designate, of the sum of Twelve-Thousand & No/100 - - - - -

- - - - - Dollars (\$ 12,000.00 - - - - -)

with interest thereon from the date hereof at the rate of Four - - - - - per centum per annum, said interest to be paid on the 1st - - - - - day of January - - - - - 19 48 and thereafter said interest and principal sum to be paid in installments as follows: Beginning on the 1st - - - - - day of February - - - - - 1948, and on the 1st - - - - - day of each month thereafter the sum of \$ 72.72 - - - - - to be applied on the interest and principal of said note, said payments to continue up to and including the 1st - - - - - day of December - - - - - 19 67, and the balance of said principal sum to be due and payable on the 1st - - - - - day of January - - - - - 19 68; the aforesaid monthly payments of \$ 72.72 - - - - - each are to be applied first to interest at the rate

of Four - - - - - per centum per annum on the principal sum of \$ 12,000.00 - - - - - or so much thereof as shall from time to time remain unpaid and the balance of each monthly payment shall be applied on account of principal. Said principal and interest to be paid at the par of exchange and net to the obligee, it being thereby expressly agreed that the whole of the said principal sum shall become due after default in the payment of interest, taxes, assessments, water rate or insurance, as hereinafter provided.

Now, Know All Men, that the said Mortgagor in consideration of the said debt and sum of money mentioned in the condition of the said bond and for the better securing the payment of the said sum of money mentioned in the condition of the said bond, with the interest thereon, and also for and in consideration of the sum of One Dollar in hand paid by the said Mortgagee, the receipt whereof is hereby acknowledged, has granted, bargained, sold, conveyed and released and by these presents does grant, bargain, sell, convey and release unto the said Mortgagee and to its successors, legal representatives and assigns forever, all that parcel, piece or lot of land with the buildings and improvements thereon, situate, lying and being near the City of Greenville, in the County of Greenville, State of South Carolina, located on the East side of North Main Street Extension, and designated as lot No. 4, Section "C" of Northgate, a plat of which is recorded in the R.M.C.'s Office for Greenville County in Plat Book K, at Page 113, and having according to a recent survey thereof made by Pickell & Pickell, Engineers, dated December 19, 1947, the following metes and bounds, courses and distances, to-wit:

BEGINNING at an iron pin on the East side of North Main Street Extension, which iron pin is 566.7 feet North of the Northeast intersection of North Main Street Extension and Avondale Drive, joint corner of lots Nos. 3 and 4 of Section "C", and running thence with the joint line of said lots S. 86-33 E. 178.9 feet to an iron pin, rear joint corner of lots Nos. 3 and 4; thence N. 4-22 E. 80 feet to an iron pin, rear joint corner of lots Nos. 4 and 5; thence with the joint line of said lots N. 88-06 W. 182.9 feet to an iron pin in the line of North Main Street Extension; thence along the Eastern side of North Main Street Extension S. 2-04 W. 75 feet to an iron pin, the point of beginning.

Being the same property conveyed to me by J. A. and P. F. Cureton by Deed dated February 6, 1942, and recorded in said Office in Deeds Volume 242, at Page 281.
